Thank you for your email of 20 December 2019 which requested the following information:

*Please provide me with the actual expenditure costs for delivering and sustaining the RAF's Reaper programme from 1 October 2006 until the end of the 2019/20 financial year.*

*If you are able to break down costs into a) revenue costs and b) capital costs for each year of the programme, as well as provide a total figure, I should be most grateful.*

*Please include the costs of purchase of the Reaper aircraft and the costs of contractor logistics support in the figure.*

*Please do not include costs associated with the Protector programme.*

I am treating your email as a request for information under the Freedom of Information (FOI) Act 2000. A search has now been completed within the Ministry of Defence (MOD) and I can confirm that information in scope of your request is held. You will find the information attached alongside this letter.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
